


UAE at a glance

- 9.68 million population
- 10% UAE National / 90% Expats
- Government is a Constitutional Monarchy
- Country only 49 years old
- Global placement in GDP per capita: 5th
- US Exports to UAE in 2019: USD 24.4 billion
- Longtime ally of US
- Strategic Location as trade hub between East and West
- Recognized as regional benchmark


COVID arrived



- First known cases in UAE Jan 28th
- When they say Lockdown, they mean Lockdown
- UAE hit earlier, unified identification (testing), mitigation (lockdown) and staged re-opening.
- Money for PPE, medical devices, equipment and economic protection and recovery programs

UAE Health Expenditure

- 2018 UAE overall healthcare spending was USD 15 billion
- 66% spending by UAE government
- 2019 onwards the private sector growth increased : Government fosters new model – PPP
- From 2018 to 2022, the private sector healthcare spend is set to grow at a CAGR of 9.5% compared the government contribution of 4.4%
- Seeing privatization of hospitals and more integrated health system

UAE's Successful PPP Model

- Budgetary constraints to achieve healthcare excellence in infrastructure and patient care
- Mergers, acquisition and strategic tie-ups between healthcare stakeholders, public and private entities
- Examples
 - Malaffi, the Abu Dhabi's unified health information exchange platform is a joint venture between the Department of Health and INJAZAT Data Systems
 - "Unison", PPP between GE Healthcare, UAE MoHP & Abu Dhabi International Medical Services – creating 11 radiology departments with the best healthcare technology, hospital management, and patient care

UAE Medical Device Market

- Very VERY little local production/manufacturing of medical devices
 - <u>BUT</u> the Pharma and Medical Equipment sectors are targeted by Dubai Industrial Strategy 2030
- UAE Medical device market forecasted to grow USD 1.3 billion (AED 4.9 billion) by 2021
- 18 major multinational medical device companies & 10 global pharmaceutical giants use Dubai as regional distribution hub
- UAE domestic and re-export market by greatest \$ size: Consumables, Diagnostic Imaging, Dental, Ortho, Aids, Other Devices (Ophthalmic, Hospital Furniture, Other Instruments, Medical/Surgical Sterilizers, Ultra-Violet/Infra-Red Apparatus

Home Healthcare

- Cultural attitude towards elderly family members
- New UAE retirement visas
- Medical home healthcare is growing
 - Medical professional home visits
 - General elder care
 - speech therapy
 - post–surgical nursing care & rehabilitation from injuries
 - Telemedicine for ongoing medical advice and services

UAE Government Healthcare Structure

- Ministry of Health & Prevention
 - SEHA
 - Abu Dhabi Department of Health
 - Dubai Health Authority/Dubai Health Corp.
 - Dubai Healthcare City
- 45 government hospitals
- 98 private hospitals
- Malafi Abu Dhabi
 - 1st in region platform up and running
- Mandatory Health Insurance









UAE Medical Device Import Regulations



- Medical devices must be approved and registered by MoHAP Drug Registration and Control Department, 5 year validity
- If no local office, manufacture/exporter needs written contract appointing a local representative
- Make sure the local representative is licensed to import your specific type of medical devices by the MoHAP
- Must maintain objective evidence on the safety and effectiveness of the medical device – that's why your company or your rep needs to be licensed to do business in UAE.
- MoHP's Registration and Drug Control Department accepts accreditation of conformity assessment bodies from the European Union, Australia, Canada, the United States, Japan, and Singapore
